**Living abroad tax deadline**

*Tags: Filing season, deadlines*



Living abroad? Don't forget to file and pay any taxes due by Monday, June 16, 2025. This #IRS deadline applies to both U.S. citizens and resident aliens abroad, including those with dual citizenship. <https://ow.ly/yXy650W02aB>

If you're living and working abroad, you have until Monday, June 16, 2025, to file your 2024 federal income tax return and pay any tax due. Can't meet the deadline? You can request an extension to file, but not an extension to pay. #IRS <https://ow.ly/yXy650W02aB>

U.S. citizens and resident aliens abroad, including those with dual citizenship, need to file their 2024 federal income tax return and pay any tax due by Monday, June 16, 2025. <https://ow.ly/yXy650W02aB>




Tell your loved ones: The #IRS will NOT contact you to ask you for credit or debit card numbers over the phone or by e-mail, or text, and most certainly not on social media. Scammers can be convincing when they impersonate government agencies like the #IRS by using fake names or spoofing caller IDs. Give your loved ones a hand by learning how to identify these scams and report them.

Spread the word to your loved ones: #IRS doesn't unexpectedly contact taxpayers demanding personal info, payments or threats of lawsuits or arrests. Beware of these scams and report them:

In the wake of recent natural disasters, the #IRS urges you to beware of fake charities. Here's how you can make sure your personal and financial information stays safe when you donate:
