If you're concerned about lowering your fuel bills and making your house more comfortable, you should look into Weatherization.

Capstone Community Action offers No-Cost Weatherization services to Vermonters in our service area who meet income and other qualifications.

Weatherization services include an energy assessment to find out how your house can be made more energy efficient and comfortable. We then provide energy renovation services, including adding insulation, fixing holes, caulking cracks and gaps, and improving ventilation. Recipients of Weatherization grants receive these services at no cost to them, and typically see a reduction in home heating bills as a result.

If your household qualifies, you'll receive:

- A visit from our Efficiency Coach, explaining the effects weatherization will have on your home and informing you how to operate the home after weatherization to ensure optimal energy savings, lasting durability, and improved air quality.
- An energy assessment to identify the areas where improvements can be made in heating, efficiency, and comfort.
- Free lighting and appliance upgrades where applicable in partnership with Efficiency Vermont.
- Renovation construction services from a qualified crew, including materials and supplies.

All at no cost to qualifying households.
